11 Rakaia Salmon Sculpture Refurbishment

The recommendation to fund the refurbishment of the salmon sculpture wasn't fully supported. Those speaking against were disappointed at the cost and the lack of comparative pricing for a new structure. It was suggested that the project be deferred until the next Annual Plan and considered alongside other projects, and that a separate reserve fund be created for the upkeep of this and similar structures in the future.

Officers advised that replicating the structure would also be costly and construction would be complicated. Repair work is now urgent and Council's flexibility and consideration of expenditure between annual plan processes is sought. Delaying work could result in greater cost or leaving the structure unable to be repaired.

Those in support agreed to the restoration being undertaken by the original artist, with costs of up to \$297,000 being met from the reserves fund.

The Mayor acknowledged the iconic status of the sculpture which had been a well-intentioned Rakaia Lions Club project, gifted to the district in 1991.

- 1. **That** Council approves the expenditure of **up to** \$297,000 plus GST from the Reserves Contribution reserve for the refurbishment of the Rakaia Salmon Sculpture.
- 2. **That** Council awards the contract to refurbish the Rakaia Salmon Structure to Phil Price Structures Ltd for \$215,000 plus GST.

Officers reported that a cost sharing approach is being taken this year as a transition; however Rotary has been advised that any future requests for funding will need to be applied for through Council's annual grants process.

17 Naming of Ashburton Art Gallery and Museum

The Mayor welcomed Te Rūnaka o Arowhenua Chair Fiona Pimm and Ūpoko Tewera King who were joined by other Arowhenua representatives. On behalf of Council the Mayor thanked them for the gifting of "Rokowhiria" as a the name for the Ashburton Art Gallery and Musuem.

Tewera explained how the name was created – Roko depicts the Māori deity Rongomātāne, god of agriculture, abundance, creativity and space. Whiria is derived from 'whiri' which means to twist, plait, weave and spin.

Council accepted the name with honour, noting that it is the anchor for the final consolidation and merging of the art gallery and museum activities.

That Council accepts the name Rokowhiria gifted by Te Rūnaka o Arowhenua for the Ashburton Art Gallery and Museum.
