Pickleball

Ruben Garcia gave an overview on Pickleball.

- Ruben is employed by the Ashburton District Council as the Communications Manager and is also President of the Pickleball Association in NZ.
- The Association are keen to discuss with the Board around using a court in the Domain.
- If there is not the need for the tennis court in the Tinwald Domain Ruben is keen to see if the Board would like to see the courts redesigned to Pickleball.
- With 1 tennis court you can develop 3 pickle ball courts. Ruben believes that this development would be an amazing asset not only to the Tinwald Domain but also the Ashburton district.
- Ruben is keen to have just a sole Pickle ball court and see this as a point of difference as opposed to a shared court. Courts resurfacing cost could be around \$50,000
- The Board is keen to assess what needs to be done for this project to go ahead. A meeting on site to be set up after lockdown.

- Steve discussed the audit report of the district pool. The Board need to decide what to do for this summer.
- An assessment on the changing rooms is being undertaken and a report will be provided to the Board.
- EA have been asked to provide swimmer numbers over the past five years.

General Business

- The front fence repair project is on hold due to Covid.
- Ian Soper is to undertake pruning along the pony paddock tree line. The developers that did unsanctioned work on this, will pay \$2,500 to the repair cost.
