4. Methven Community Board Minutes – 1/05/23

Minutes of the Methven Community Board meeting held on Monday 1 May 2023, commencing at 10:30am, in the Mt Hutt Memorial Hall Board Room, 160 Main Street, Methven.

Waka Kotahi - 10.25am-11am

James Long (Senior Safety Engineer, Transport Services) was welcomed to the meeting and invited to update the Board on a meeting held in February with local school principals and Deputy Mayor Liz McMillan. The meeting talked about what could be done to improve safety and upgrade pedestrian crossings near the Methven schools.

James advised that the option of using a Kea Crossing is unlikely in Methven. This type of crossing is patrolled by approved members of the school community who use signs to stop traffic and allow pedestrians to cross the road. The local principals have indicated they will struggle to get enough volunteer support to supervise children at the crossing points. Instead, Waka Kotahi are recommending a raised safety platform which controls vehicle speed and has the added benefit of providing a 24/7 safety solution. The raised platform may result in some carparks being removed near the existing crossing and cost efficient solutions are being sought.

The Methven-Chertsey Rd / Main Street intersection was also highlighted as an issue with a suggestion that a small roundabout may be better at this site, and another pedestrian crossing could be constructed to the south of the intersection. Board members commented on the amount of underground infrastructure and the creek that runs through the Methven-Chertsey Rd which may make roundabout construction difficult.

James advised that the proposal will be kept to the fore when Waka Kotahi are looking at priorities for Mid Canterbury, but there's no immediate funding available and, realistically, these upgrades would be from 2024 onwards.

On other issues relating to Methven, James reported that Waka Kotahi have confirmed a 30km/hr variable speed zone near Our Lady of the Snows School which will operate at certain times in the morning and afternoon.

Feedback from consultation on the Interim Speed Management Plan showed that the community didn't support the 80km/hr speed reduction near Ōpuke pools. Waka Kotahi have since reviewed and are now planning to reduce this further to 60km/hr. Timing for the speed limit changes is uncertain – the Interim Safety Management Plan is to be sent to the Director of Land Transport for sign-off later this month, and a further 5 weeks is anticipated before it's finalised. A timeline for the implementation plan, and where Methven fits into Waka Kotahi's overall timeline, is currently unknown. It could potentially be 12 months out.

The Chair asked whether speed calming measures, such as those on SH1 at Burnham and Rolleston, could be used in Methven, particularly with the anticipated increase of traffic during the ski season. James explained that Methven doesn't meet the strict criteria for this to happen. It's also not an option to look at this under temporary traffic management.

The Chair thanked James for his presentation and asked if the Board can be kept updated.

5 Proposed Time Restricted Parking

The Supermarket owner has asked for the entire carpark to be one hour parking, but this is not the officers' recommendation. Jane Donaldson reported that officers have prepared a short survey that will go to the Methven property owners and tenants to get feedback on whether they support the proposal, prefer the status quo, or have another suggestion. The Board will be updated on the outcome of this in June.

That the Methven Community Board approves consultation with property owners and businesses located in Methven Mall on the proposed introduction of a one hour parking restriction for 10 of the 15 car parks adjacent to the Supervalue supermarket.

7 Methven Community Board discretionary Grant - Methven Squash Club

The Chair noted the total cost for repair of the courts and recommended that the grant be increased to \$6,000. He acknowledged Board members' concerns that a leaking roof has contributed to the court damage and agreed to raise this with the Squash Club and see what the Club's plans are for roof repairs.

That Methven Community Board allocates \$6,000 from its discretionary grant to the Methven Squash Club for the re-painting of their courts.

Extraordinary business - Walking Festival

Cr McMillan thanked the Board for the \$1500 discretionary grant which was used for the large signage. The Walking Festival was deemed very successful with approximately 700 people taking part. The Enchanted Forest walk / Family Day was particularly popular (over 450 people) as was the Easter Egg hunt held at Awa Awa Rata reserve.

The event organisers are planning for another event next year, again in conjunction with the Methven Scarecrow Trail. A survey of approximately 100 participants at this year's festival is being undertaken.

Income and expenditure

The Board received the income and expenditure reports for February and March 2023.

Revenue & Financing Policy – drinking water

The Board agreed that the Chair will prepare and submit a submission to Council prior to the deadline of 7 May 2023.

• Transportation Bylaw

The Board noted the intention for the Bylaw to be updated with minor changes.

Discussion followed on the issue of heavy vehicles parking on residential streets, which is not permitted. Officers advised that reports of illegal parking are followed up with the offending companies by Council's Roading Team. Board members can review the consultation documents which include Methven streets.

CRM report

The CRM report content will be reviewed. Board members concluded that the information isn't entirely accurate and that there are more completed requests for service than the report suggests.

• Building services

It was reported that glazing rules have changed from 1 May 2023 that apply additional insulation requirements to new buildings, including triple glazing.

Methven tree lighting

Simon Worthington outlined the issues that have arisen with attempts to install new festive lighting in Methven, including the re-lighting of two oak trees. To meet the required safety standards, Electricity Ashburton would have to lift pavers and dig up infrastructure to lay cables to the trees and this work is cost prohibitive.

The recommended approach is to undertake a full assessment of the power supply and load capacity and work with a lighting designer to create a lighting solution. This will be in consultation with Waka Kotahi and Council.

As part of this staged approach, Spectrum has been engaged to develop a lighting plan with a consistent theme through Methven – they'll show what's possible and what the cost effective options are.

Simon will seek the Board's support for a business plan he is preparing for Council's LTP 2024-2034. The Plan for Methven's lighting solution would see (in the first year) investment in electrical infrastructure. Some interim work could be undertaken in the meantime including getting businesses on board.

Officers will continue to support the Methven Lighting Committee and the Board will be updated again on 12 June.

District promotion

Simon will be attending the TRENZ event in Christchurch next week where he will be representing the district's operators. He acknowledged that the Board wants to have greater input into the process to ensure Methven is well promoted.

The Board heard that the first step is to update and refresh the content of the District's story and utilising the "Neat Places" site.

Roading

The Chair reported that he will be meeting with Council's Roading Manager, Wareings and Methven Trucking this Friday to look at the siting of the new kerbing on Line Road. The kerb will need to accommodate large vehicles turning.

Watermain renewals

The Board would like further detail on where the renewal work is being carried out. A map showing locations would be appreciated. [Post meeting note: map of watermain sites has been emailed to Board members]

Reserves

It was reported that Methven Lions plan to tidy up the Mt Hutt Station Road walkway on SH77. Work is pending a traffic management plan which is being followed up by Robin.

Methven Cemetery

The Chair advised that Methven Lions have a number of plants to contribute to the cemetery landscaping and will liaise with the Open Spaces Manager to fit in with the planting programme.

5. Time Restricted Parking – Methven Mall

Summary

Consultation on the proposed introduction of a one hour parking restriction for 10
of the 15 angle parks in Methven Mall has been carried out. The consultation has
produced no clear outcome.

Recommendation

 That the Methven Community Board recommend to Council that a 30 minute parking restriction be introduced for 5 of the 15 angle parks adjacent to the Supervalue Supermarket in Methven Mall.

Background

- The Board was advised at its last meeting that a request had been received from Methven Supervalue for a time limit to be applied to parking in Methven Mall because at times there was a shortage of parks available for supermarket customers due to some vehicles parking for extended periods of time.
- 2. The Board approved a recommendation to consult with property owners and businesses located in Methven Mall. A letter was sent to property owners and hand delivered to each premises in the Mall. It outlined the proposal and included a QR code to access a short survey asking if the proposal or the status quo was supported, or if another option was preferred. A hard copy of the survey was also provided.
- 3. Consultation closed on 21 May, with 14 responses received. A summary of the responses is as follows;

5 of 14 do not support the proposal and want to leave the parking as is.

Comments:

- Multiple businesses require more than 1 hr parking
- No positive outcome
- Discussing the biggest asset in a person's life isn't a 1 hour job

5 of 14 do not support the proposal and want it changed to something else

Comments:

- Also allocate parking to other businesses
- Allocate just 4-6 spaces in front of Supervalue
- Install 5 x 15 minute spaces in front of Supervalue
- Educate staff not to use spaces
- 1 hr timed spaces for whole Mall
- Provide 4-6 x 30 minute timed spaces.

6. Activity Reports

6.1 Democracy & Engagement

6.1.1 Western Ward By-election

The final result for the by-election that closed at midday on Friday 12 May was declared by the Electoral Officer on Monday 15 May. Rob Mackle was elected, receiving 686 votes. Hayden Tasker, Lynda Topp and Carol Johns received 491, 432 and 135 votes respectively. The voter return for the by-election was 41.94%.

Cr Mackle was sworn in at the Council meeting on 17 May 2023, and has been appointed to the Methven Community Board.

6.1.2 Strategy & Policy updates

• Revenue & Financing Policy - Drinking water

The Methven-Springfield Water Supply Revenue and Financing Policy consultation closed on 7 May with 29 submissions received. The consultation material can be found here.

A Council hearing was held on the 31 May with one submitter speaking. Council considered the submissions and feedback and agreed to the Methven-Springfield water supply joining the District Water Group, the preferred option of 1.2+1 and the removal of the half charge.

Transportation and Parking Bylaw

The Transportation Bylaw consultation closed on 14 May with 17 submissions received. The consultation material can be found here. The purpose of the Bylaw is to set controls for the use of roads and footpaths in the district by all types of traffic so we can ensure the health and safety of people, prevent nuisance to the public and protect transportation infrastructure from damage.

A Council hearing was held on 31 May with two submitters speaking. Council considered and made decisions on the submissions with the final bylaw to be prepared and adopted on 28 June.

Economic Development Strategy consultation

Council approved a draft Economic Development strategy for consultation on 17 May. Consultation opened on 22 May and closes on June 18. The strategy includes three areas of focus, goals and an action plan. The consultation material can be found here.

Reserve Management Plans consultation

Council approved consultation on the development of Reserve Management Plans. The first round of consultation is scheduled to begin on 6 June across the district. The first round seeks general feedback around the district's parks and reserves to enable the development of Draft Reserve Management Plans for a further round of consultation early 2024. When available, information will be under Council consultation page.

• Long Term Plan 2024-34 development

Work is underway on the development of the 2024-34 Long Term Plan, with a number of initial steps including planning for early engagement LTP consultation, preparation of base information and assumptions, and officer development of Activity Management Plans. This work will continue over the next 12 months.

6.3.2 Economic Development

Methven Tree Lights

Spectrum Lighting have been engaged to develop a lighting plan for Methven. This will cover Main Street (Dubliner Pub to just past the Methven Hall), Forest Drive to McMillan Street, McMillan Street to the Roundabout and The Mall.

Officers are currently waiting for the plan and costings, once known this is likely to become a business case for potential inclusion to the LTP.

Tourism

TRENZ

Officers attended TRENZ in Christchurch in early May. A pre-famil with 16 international buyers took place on the day prior to TRENZ. The buyers toured the Inland Scenic before stopping at the Staveley Store for a paper bag morning tea and then the Opuke Pools. After a soak it was off to lunch at Farmers Corner with the Mayor and then a visit to the Aviation Museum before returning to Christchurch.

At TRENZ we met with over 50 International Buyers and presented options for how they could engage with the region and local operators. The buyers were really interested in the Methven area and the Inland Scenic Route.

Operators Meet-up


Officers recently met with Tourism Operators from across the District to provide an update on the work that has been undertaken since taking the programme back from ChristchurchNZ. Officers took the participants through the latest data and our suggested approach to fiscal 2023/24. The session was really positive and there was a genuine willingness to work together.

Tourism Spend

- Total tourism expenditure increased by 19.4% in the year to March 2023. (30.5% NZ, 23.8% in Canterbury).
- Total tourism expenditure was approximately \$117million in Ashburton District compare with \$98million a year ago.

Annual total, Ashburton District (\$m)




Guest Nights

- Total guest nights in Ashburton District increased by 47.3% in the year to March 2023, compared to a year earlier. This compares with increases of 54.2% in Canterbury Region and 52.0% in New Zealand.
- Visitors stayed a total of 250,100 nights in Ashburton District during the year to March 2023, which was up from 169,800 a year ago.

6.4 Infrastructure & Open Spaces

6.4.1 Roading

Waka Kotahi has been contacted about installing signs in advance of the public toilets (e.g. Public Toilets 300 m). They are considering the installation with suitable locations in an urban area – a challenge to ensure they do not conflict with other signs, etc. and are visible to drovers.

A new footpath will be constructed on Mackie Street following the water main upgrade which had been brought forward but is now programmed for late June 2023. The alignment of the water main is now to be in front of the kerb and channel so does not directly affect the footpath construction, but the laterals need to be constructed across the line of the footpath. The footpath construction will be undertaken as soon as the water main upgrade has been completed.

New footpaths and associated kerb and channel on Dolma Street and Line Road are included in the programme of works funded from the Three Waters Better Off Funding. The alignment of the kerb and channel and footpath will be such that the seal will be widened to allow room for the heavy vehicles that turn in and out of the businesses along Line Road. The contract is planned to be awarded within the next two months with completion of by Christmas 2023.

Dig-out repairs on Forest Drive and Pudding Hill Road have been completed.

6.4.2 Drinking Water

Membrane plant

Work on the membrane plant building is progressing as per schedule. Steel frames, roofing and walls are almost completed. The membrane skids have been delivered on site and will be installed in the next 3 weeks.



• Reservoir

Commissioning of Tank No. 2 commenced and is scheduled to be completed 14 June 2023, weather permitting. The tank can be filled and used to supply the town thereafter. When operational the two reservoirs will provide Methven with at least 18-hours of average daily water supply.




The investigation on the structural integrity of the concrete tank is complete. The report has been submitted by BECA. Council staff are presently reviewing the report and the recommendations presented. A summary of the report will be presented to the Board meeting in July.

Fluoridation

The maintenance contractor has loaded the last remaining bags of fluoride into the existing system. This is expected to last until around the end of March or mid-April depending on scheme demand. Fluoridation will therefore cease at this time until the new water treatment plant is commissioned. Appropriate information will be provided to the community in the next few weeks. The Director General of Health will also be advised of the situation.

• Watermain renewals 2023/24

The tender for water pipeline renewals 2022/23 has been awarded to Ashburton Contracting Limited. It is programmed that work in Methven will commence in late June 2023.



The sites of the renewals are Main Street (between Forest Drive and McKerrow Street), Mackie Street (Between Barkers Road and Kilworth Street) and Kilworth Street (from Mackie Street to the end of legal road (showgrounds)). The areas are highlighted in the drawings above.

• Methven Springfield water meter installation

ACL completed the survey for backflow level of risk, restrictor checks and identification of the actual number of water meter manifold/backflow setups needed for properties in the Methven-Springfield scheme. Installation of water meters to 70 properties has commenced. The aim is to have all meters installed by 30 June 2023, weather permitting.

6.4.3 Open Spaces

Reserves

Staff are currently busy undertaking Autumn maintenance tasks around the town. Leaves are a large part of the workload and prove challenging when the lawns are still actively growing. This clean-up will be ongoing in the coming months. Staff have completed the central business district spray round and note there is still active germination and growth especially in paved areas which hold the heat.

There has been additional planting in the gardens behind Mt Hutt Hall and staff have scheduled in additional mulch needed for this site, which will occur in the coming month. Also in the central business district, the annual bedding plots have been renovated with new seasons plantings now in the ground. This will provide for a colourful winter and spring display.

Street trees on Cushmor Drive have been pruned. Over winter all other street trees will have a maintenance lens over them with any required work actioned. The treeline of Wellingtonia on Mt Hutt Station Road towards Ōpuke have been pruned by ADC staff. The Methven Lions have been contracted to undertake a cleaning up of the site. This is as a result of the initial trim of the trees when the path was surfaced being a little average. As this is a main entrance to the township and a popular walking route to the North, it was agreed by all that a higher level of service was required here.

Over the past month staff have met with the Methven Reserve Board to discuss several of their concerns around the domain. Some remedial actions have flowed from that positive discussion.

June will see Council approved public consultation kicking off the process of updating and constructing Reserve Management Plans. Initial consultation will include a focus group meeting to be held in Methven for District Reserve Board members. A separate event will be scheduled for consultation with the Methven Community Board, prior to the Reserve Board's meeting on 13 June.

Playground repairs have commenced in Methven with work on Spaxton Street playground underway at the time of writing. Next will be the CBD playground on the railway reserve. It is expected that all work will be complete by 30 June.

Staff are continuing to work in the planning stage of development for the Methven Dog Park. This will include canine enrichment features to be incorporated into the Methven Dog Park. Feedback will be sought from the Community Board in due course.

Staff have a delay and holdup with the CBD seating and litter bin woodwork replacement project. This is because we are currently recruiting for a Maintenance Lead staff member. An appointment has been made with the new role-holder due to start on 19 June. A further compounding matter is the supporting staff member being currently off-work.

Methven Cemetery

Staff continue to undertake weed control on the new bund and around operational Cemetery areas. Additional plantings have occurred on the site and mulch is progressively being spread around the plantings. Staff are planning to meet with Community planting groups to discuss where we do and do not want additional revegetation plantings to occur onsite. This is to not overly encumber site maintenance.

Four new park benches have been installed at the Cemetery. This will be beneficial to particularly older community members and provide them opportunity for contemplation and reflection.

The replacement and new hedge line has also been planted at the northern end of the Cemetery. Once established and affording some weather protection from the North, the old and existing hedge-line will be removed.

Public toilets


These are functioning well. It is pleasing to report minimal recent issues at public toilets in Methven.

6.4.4 Solid Waste Management

Methven drop-off yard

Funding for the development of a transfer station at the Methven drop-off facility has been approved in the capital renewals programme of the 2024-2031 Long Term Plan. Staff would like to seek the Board's opinion about the location of the existing Methven recycling drop-off yard.

The existing recycling drop- off yard is in the corner of Methven Chertsey and Line Road.



It is proposed that the green waste drop-off at Vaughan Road be relocated beside the recycling drop off yard highlighted by the red-dashed line on the drawing above.

Staff are seeking Board members' views on whether the Board agrees that the existing recycling drop-off yard is the most appropriate long-term location for the both the recycling and green waste yard.

It is my understanding that the only reason this issue has been raised is because Supervalue felt they had limited parking for their customers (both elderly and drop-in) within close proximity to their business. These shortages are also only for a brief period of time during peak hours of the day i.e. 3pm - 7pm. It needs to be understood that the majority of people who visit Supervalue in Methven (both visitors and residents) will only attend the supermarket for a brief period of time. This submission is following my original paper version, and after I have had time to consider the actual issue at hand, and the long term effects of the proposed 60min car parking spots.

The issue that has been raised by Supervalue does not exist for every hour of every day.

A large number of the businesses in the mall surrounding Supervalue are personal services businesses, ie massage, hair, tattoo & beauty. The average booking time for these businesses is around 1.5hr.

Therefore a 1 hour time limit would restrict the majority of our customers from parking in the vicinity of our businesses.

I operate The Salt House over 7 days, any time between 9am and 9pm and I only see a squeeze on parking between after school hours (around 3pm) through to about 7pm when the supermarket closes. There are no issues during regular business hours and there are definitely no issues on a weekend where the Mall looks like a ghost town.

Like the Supermarket, my business also has elderly and those people deserve the opportunity to park close to where they intend to shop.

I observe on most days staff from neighbouring businesses parking their cars throughout the mall which for the most part are there for up to 8 hours. So if we asked local business owners to ask their staff to park on the surrounding side streets, the mall would have plenty of parking available for customers at all hours of the day.

I do not want to see the Council introduce 10×60 min parking spots because this will not actually achieve anything, other than to give people the authority to park there and shop anywhere throughout the town. Obviously this achieves nothing to support the Supervalue issue, or the stakeholders who rely heavily on the Mall parking for their customers.

I would ask the Council to reconsider the 60min planned signage and look to change this to just a handful of 15min spots which will have a great and positive effect to all stakeholders.

I would also ask that Council consider engaging with the business owners directly and ask them to have their staff park outside of the Mall area which will help the situation immensely.
