Site set for water quality trials

Six shipping containers with their tops and bottoms removed were craned into a canal at Lake Hood this week, for the first stage of water quality trials this summer.

The containers are partly submerged and scientists will be testing a range of algalcontrol products targeting cyanobacteria.

Infrastructure Group Manager Neil McCann said the shipping containers would remain for a month and then be removed.

"The aim of this work is to test products on the water captured in the containers and prepare for a more scientific trial in February or March when cyanobacteria levels are expected to be higher. One of the containers is an untreated control container and the other five will be testing three chemical and two biological products."

Scientists are monitoring cyanobacteria, chlorophyll-a, total N, total P, pH, dissolved oxygen, turbidity and temperature.

Signs erected at the trial site inform residents and visitors about the work.

Mr McCann said the lake was preparing for a busy summer and the weed harvester had already begun regular patrols, cutting and removing weed as required. A full closure of the lake is also planned for 29 and 30 November, to enable the holding of a club rowing regatta.

The event is free and people are encouraged to bring a picnic blanket or a chair and find a nice spot on the grass to enjoy the evening's entertainment.

The giant six-metre Christmas tree is being assembled next week, with the help of EA Networks. There are about 1600 baubles that will glow in the dark.

SHORT SWEET

SAFE DISPOSAL

Council is urging residents to keep contaminated coloured sand products out their kerbside rubbish bins and instead bring them to the Ashburton Resource Recovery Park from Thursday this week. Some coloured sand products have been recalled by MBIE after independent testing confirmed the presence of tremolite asbestos. The sand needs to be in a sealed container and double-bagged. Bring it to the

Bring it to the drop-off lanes in the recycling area, and alert staff.

CLEAN YOUR RACES

Now's the time for checking and cleaning any stockwater races on your property. For all users to have access to the water, no matter where they are on the network, it is important that a clear and continuous flow is maintained – plastic buckets, baleage wrap, weeds, hedge trimmings and other debris can all block races and result in overflows or water being wasted on land or roads.

KEEP KIDS SAFE

Pools can be dangerous for young children and any pool (permanent, portable or temporary), that can hold 40cm or more of water needs a fence or barrier that restricts access to keep children safe. MBIE has published a swag of information about the requirements that apply to different types and sizes of pools and is running an awareness campaign with safety guidance. LOW PRESSURE

Households on the Ashburton drinking water scheme might experience periodic low pressure for the next month while contractors upgrade the Ashburton Domain water treatment plant. The upgrade involves adding UV equipment to the treatment process, as required to comply with national drinking water rules. The plant has been shut down until 17 December; the town will be supplied from water plants at Argyle Park, Bridge Street and Tinwald until then.

Digouts, linemarking first on roading list

Council's new roading operations and maintenance contractor **Fulton Hogan Ashburton will** initially concentrate on digouts and linemarking when it takes over the job on 1 December.

The five-year, \$40.7 million contract also involves pothole repairs, replacing road signs, grading, street cleaning and ice gritting, and local companies have been sub-contracted to help out.

Infrastructure Group Manager Neil McCann said Fulton Hogan wanted to start the digouts early to make sure more could be done before Christmas.

"Digout repairs need good weather to have the best results and are calculated by the square metre. Over the life of the contract, Council expects over 87,500 square metres of digouts to be achieved.

"A digout is one of the most common repairs we carry out on our network and they are essentially for big potholes or pavement failures that can't be permanently repaired with a pothole mix."

The maintenance contract is a mix of routine work, like grading and fixing potholes, as well as programmed work like seasonal ice gritting and weed spraying.

Mr McCann said several sub-contractors would support Fulton Hogan.

"Tarbotton Land and Civil will continue to do the grading on our unsealed roads, Philip Wareing will do the ice-gritting, Delta will deal with the weeds and Wasteco will do the street cleaning.

"Fulton Hogan has the plant and equipment they need and a wellestablished team in Ashburton to maintain the condition of our roading network."

Plans made to hook Rakaia's big salmon

Sculptor Phil Price had his measuring tools out last week at the Rakaia salmon, riding up in a cherrypicker to inspect where the lifting hook will make contact.

The plan is to remove the salmon before Christmas for a major renovation, but getting it off its support stand and back on is a big logistical exercise.

The sculpture is about 12m long and weighs 1.6 tonnes. It was constructed with an internal fitting so it could be lifted with a hook and Mr Price went up last Thursday to check the hardware was in working

Once the lifting hook is made up and the big fish is hooked by crane, it will be cut off its steel support and then gently lowered onto a truck for transport to Mr Price's studio in Waltham, Christchurch.

Group Manager of Community and Open Spaces Toni Durham said Mr Price would also need to build a special cradle for the fish to rest on while undergoing repairs. It will also allow the fish to spin in situ.

"The size of the sculpture makes it fairly



tricky to manoeuvre. Once it's on the back of the truck, it will have a quick stop-off in Hornby for sandblasting before Mr Price and his team begin the refurbishment at his studio.

"We're lucky to have the services of Ashburton Crane at a reduced rate to lift it off and on, and then Tarbotton Land & Civil have also offered to transport it without charge. We'd also like to thank EA Networks for the use of their cherrypicker at a reduced rate."

Mini golf bookings open

Mini golf enthusiasts can now book a round at Mini Mid Canterbury, the district's new mini golf course.

The 18-hole course opens to the public on Saturday and players can book using the EA Networks Centre's website, via the Bookings tab.

If you have your own golf equipment, the course is free to play on. Putters and balls can also be hired at the EA Networks Centre reception for \$5 per person, during opening hours; players can also scan a QR code to bring up a digital scorecard.

Bookings can be made for groups of up to 10 players.

Mayor Liz McMillan will officially open Mid Mid Canterbury on Friday, and councillors have been invited to take part in the inaugural round.

The course has been inspired by the district's unique landmarks.
