

Time to celebrate local business

It's less than a month now until the ANZ Business of the Year Awards gala dinner on 20 February.

Organisers say that ticket sales for the R18, black-tie event are already ahead of previous years, and they are expecting more than 300 guests.

Ashburton District Mayor Liz McMillan says that all business owners are invited to go along, not just finalists.

"It's a great opportunity to celebrate, get inspired and do some networking with fellow business owners.

"Since these awards began in 2021, lots of local organisations have done well out of being recognised, and the contacts they have made.

"We're proud to be backing our local companies, whether they're big or small, new or experienced, and this event recognises the whole range."

The awards gala dinner will be held at the Ashburton Aviation Museum's superhangar beginning at 6pm on 20 February. The aviation museum was a tourism award winner in 2022.

After receiving a glass of bubbles on arrival at the 2026 gala, guests can expect a special three-course dinner prepared by chef Chanaka Jayabahu of ARC Culinary Cruise, entertainment and a cashless bar.



The awards attracted 116 entrants which were shortlisted by judges to 50 finalists across 15 categories.

The judges were former mayor Neil Brown, Jason McCrae from Business Canterbury, Chantelle Quinn of the Braided Rivers Community Trust, and Willie Murney of Murney Trust.

They said there was a consistency across all applications and entrants showed passion for what they do, who they serve, and the wider Mid Canterbury community.

The judges also said the entrants impressed them with in-depth business knowledge and insights.

Category winners are eligible for the supreme business excellence award, which will be decided by Mayor Liz McMillan.

Challenges of Local Government change

Well, I'm just over two months into my role as your Councillor for the Eastern ward, a position I took on to give something back to our great community.

The job has grown significantly since our election, with changes and proposed changes to local and regional government.

Early this year Council will be working on the 2026/27 budget. The Government has asked Councils to keep to our core business, and from 2029 is considering legislating a maximum rate increase of 2-4%, for specific council expenditure items.

A quick look on Dr Google and I note that our long-term inflation rate averages 5.4% - a high in recent years of 18.9% in 1987 and low of 0.29% in 2015.

This target by the Government will look to place some significant challenges on Council. The easy solution is to stop inflation of all costs, but we don't control that.

Option two is to reduce the level of service provided by Council, which many would be unhappy with.

On a more positive note, the proposed Regional Government (Ecan) reforms and a review of the Resource Management Act could provide an

enabling and sustainable future for our community. The execution of existing policies by Ecan seems to restrict innovation and may frequently impede positive initiatives from being undertaken.

A local Valetta farmer has told me there is a lack of understanding by Ecan about compliance of land use consent, but surely if an A audit on a land use consent doesn't indicate compliance to a farm environment plan, then what does?

For two years, the Ashburton Lakes Catchment Group has been wanting to develop a small, constructed wetland (less than 2300 m2 - about the size of

three sections in town) to see how much they can improve water quality in the catchment.

Ecan want five or six consents to allow the wetland construction, with an estimated cost of \$50,000-\$80,000. The total construction, planting and monitoring cost has been budgeted at \$25,000-\$30,000 (depending on consenting requirements).

Where is the sense in requiring expensive consents for an activity that will enhance environmental and biodiversity outcomes?



Extra funds for roads

Council will rehabilitate another section of Fairfield Road and upgrade the Oak Grove roundabout after receiving additional funding from NZ Transport Agency.

Infrastructure Group Manager Neil McCann said the national transport agency had increased the budget for its subsidised work programme in the Ashburton District by \$2.5 million this financial year.

This will mean that Council can claim a subsidy for the \$1m of reseals and \$0.5m of unsealed maintenance metalling budgeted as unsubsidised. It also allows the proposed additional sealed road rehabilitation to be completed.

“Council’s share of that extra work is \$1.225m, and we can meet that from our



existing unsubsidised roading budget. We learned of the extra funding just before Christmas, so now we’re able to make more improvements.”

Mr McCann said Council was pleased that NZTA recognised the need for work on the network and had the resources to get the work done within the next few months.

Want to start your own business?

Council is hosting a free two-day workshop next month, aimed at helping people aged 18-30 learn more about how to start and run a business.

The King’s Trust Enterprise Workshop is being supported by the Mayors Taskforce for Jobs, which is all about helping young people into jobs. Ashburton Mayor Liz McMillan is one of 17 mayors supporting the national taskforce and she will open the workshop on Wednesday 4 February.

So, if you’ve got an idea for an app or a new service, but don’t know how to take the next step, then register and come along to the Ashburton Library on 4 and 5 February - you’ll gain practical business skills, explore enterprise fundamentals and connect with like-minded people.

After completing the workshop, you’ll have access to a 10-week accelerator course, mentoring and networking opportunities, and potential to access funding for your business.

The workshop is one of a series being run by the King’s Trust, and the Ashburton event will include presentations by local entrepreneurs like Harriet Hill, of Hemprino. Harriet is the sales and marketing director and merino wool grown on her family farm in the Rakaia Gorge is blended with hemp to make clothing that is natural, beautiful and sustainable.

There’ll be a chance to ask questions about Hemprino’s journey from concept to production.

Organisers say the enterprise workshop is geared to those aged 18-30, and is one of two being run in the South Island. People can register via, kingstrust.org.nz

The workshop is also supported by the Minister of Youth James Meager.

Older drivers

Ashburton's older drivers are being encouraged to sign up for a free refresher course aimed at helping them stay independent and driving for longer.

The Staying Safe course is supported by Council and being run by Age Concern at the Ashburton Senior Centre on **Friday 20 February**. It will be a classroom-based course, from 10am-2pm.

Drivers will be able to re-familiarise themselves with traffic rules and safe driving practices, and learn about other transport options.

ROADING NOTICES

Chalmers Avenue - Closed at the Ashburton River end until 30 January while water mains are installed.
