# 6.# District Licensing Committee Annual Report July 2015 to June 2016

### 6.#.1 Summary

The Sale and Supply of Alcohol Act 2012 requires Territorial Authorities to submit its annual report on the proceedings and operations of its District Licensing Committee (DLC) to the Alcohol Regulatory and Licensing Authority (ARLA) for the period 1 July 2015 to 30 June 2016.

### 6.#.2 Recommendation

- 1 That the report be received.
- That the report be posted on the Ashburton District Council website.
- That the report be sent to the Secretary for the Alcohol Regulatory and Licensing Authority within 1 month of adoption.

### 6.#.3 Background

Section 199 of the Act requires every territorial authority to prepare and send to the licensing authority a report of the proceedings and operations of its licensing committee in the set format below.

A copy of the report must be made available by the territorial authority for inspection free of charge for a period of not less than 5 years.

Regulation 19 of the Sale and Supply of Alcohol (Fees) Regulations 2013 also requires Territorial Authorities to prepare a report detailing income from fees and licensing costs under the Act. This includes costs relating to DLC functioning, licensing inspectors and enforcement activities relating to the year commencing 1 July 2015. While this additional information is not required to be in the report to ARLA, it must be made publicly available and is therefore included in the overall report.

### 6.#.5 Statutory Implications

The Sale and Supply of Alcohol Act 2012 requires the Council to publish an annual report on its DLC activities in the prescribed format.

### 6.#.9 Overview of DLC Workload:

### DLC structure and personnel:

The Ashburton District Licensing Committee (DLC) was appointed by Ashburton District Council from 18 December 2013 in accordance with the Sale and Supply of Alcohol Act 2012 (the Act). The DLC is charged under the Act with dealing with alcohol licensing matters for the Ashburton District and consists of the following persons:

### Work flow

In the period from 1 July 2015 to 30 June 2016, the Ashburton DLC received a total of 325 applications, a breakdown of which is attached.

### **Conferences and Training**

The Chair and Members of the Ashburton DLCs attended further training on the Act at Selwyn District Council arranged locally.

### **DLC Meetings and Hearings**

Generally, the Chairman of the DLC meets with the Secretary on a weekly basis to sign any unopposed decisions.

During the same period the DLC convened on 15 Temporary Authority Hearings 1 of which was publicly held.

### **Publication of DLC decisions**

### Any noticeable trends or issues faced by the DLC

No noticeable issues have been noted and the DLC again looks forward to participating in further ongoing training and support about the Act and its Regulations and other relevant law. The DLC would also welcome formal opportunities for networking and information sharing to improve consistency of approach nationwide.

### 6.#.10 DLC Initiatives:

No new initiatives were adopted or trialled during the reporting period.

### 6.#.11-Local Alcohol Policy

## Ashburton's Provisional Local Alcohol Policy Background:

In accordance with Part 2 subpart 2 of the Sale and Supply of Alcohol Act 2012, Ashburton District Council has developed a provisional Local Alcohol Policy (the pLAP).

The pLAP, which was approved by Council on 26 February 2015 and publicly notified on 3 March 2015, represents an updated approach to alcohol management in the Ashburton district. It is intended to provide guidance to decision-makers in applying the new Act and any amendments that may come in the future.

Key features of the pLAP are:

- •Allows licensed premises to be established in the district subject to meeting the requirements of the LAP, the Sale and Supply of Alcohol Act 2012, and the District Plan (or permitted by way of resource consent)
- Provides maximum trading hours for on licence premises
- ∘7.00am 2.00am for tavern-style operations
- ∘7.00am 1.00am for restaurants and cafes
- ∘7.00am 12.00 (midnight) Footpath areas tavern, restaurant or cafes
- •Allows the DLC to set more restrictive maximum trading hours if the granting of the application is considered to impact on amenity and good order of the locality to more than a minor extent
- •Introduces a mandatory one-way door restriction for on-licence premises in the 'Ashburton urban' area from 1.00am
- •Provides conditions the DLC may apply to licences. This includes CCTV cameras, lighting, the number of drinks that can be ordered at one time after a specified time and a one way door for premises outside of the 'Ashburton urban' area.
- •Provides maximum trading hours for all off licences: 8.00am 9.00pm (changed to 7.00am 9.30pm as a result of appeals)
- •Provides maximum trading hours for club licences:
- °Sunday Thursday: 10.00am 10.00pm

- •Friday and Saturday: 9.00am 12.00am (midnight)
- •Requires club-licensed premises to have a qualified duty manager on the premises at all times when alcohol is being sold or supplied and there are 20 or more people present.

### **Current Position:**

As at 30 June 2016, the Ashburton pLAP was still awaiting a hearing. One appeal was withdrawn (Hospitality New Zealand). The two remaining appellants (Progressive Enterprises and Super Liquor) reached agreement with the Council in September 2015. The proposed hours for off licences were extended and discretionary conditions amended. However, there are three other parties who have registered an interest under section 205 of the Act. One of these (Alcohol HealthWatch) has indicated it will not take part in a hearing. The other two interested parties (Medical Officer of Health and Canterbury District Health Board) have not formally committed their position in respect of a hearing. Council is now endeavouring to secure signatures from all parties for a memorandum of understanding that can then be submitted to ARLA for consideration together with the resubmitted pLAP. If this is accepted by ARLA, a decision can be made on the papers without the need for a hearing.

### 6.#.12 Current legislation

The DLC and the Ashburton District Council would welcome further coordinated guidance on best practice in the operation of the Act and its Regulations.

### 6.#.13 Other matters

Previous concerns raised are reiterated, namely:

- The DLC again questions the need for a full panel to consider applications for Temporary Authorities.
- Requiring paper copies of applications is time consuming and expensive and does not meet the government's stated objective of e-government.
- Monthly reporting to ARLA is also time consuming and the accuracy of monthly financial returns is also questionable. Consideration should be given to annual reporting.
