Do you have any other comments or feedback about this draft plan?

The main concern I have with the proposal is the consideration of adding a flight school to the aerodrome, which I do not support. Ashburton is ideal for a mix of general aviation and commercial activity, and I think the proposed plan allows for an increase in movements without negative impact to local residents. The airport can easily allow for a significant increase in activity - however, training aircraft and private operators may not mix well.

Training aircraft will want to fly standard circuit patterns for the largest runway which is going to lead to significant noise pollution as this will take them directly over the main Ashburton township (something the previous skydiving operation regularly avoided). Any training organization will likely want to also cover extensive night flying, which will have to be handled very carefully if curfews and noise complaints are to be avoided. The increased airport movements will also lead to significant wear on grass runways unless they are sealed (Christchurch Intl. has to regularly move the grass runway to allow it to re-grow). These concerns can all be addressed but I believe it very important that the Ashburton aerodrome maintains a positive relationship with the Ashburton residents.

My concern is that Ashburton residents may not be aware of just how much additional traffic a flight school will bring, despite a relatively small financial upside. Ashburton is already the home to a great local general aviation community, and I would rather see this expanded with hangars, hangar homes, and commercial operations. This allows the airport to remain the center of events such as the NZ Aerobatic Nationals and Flying NZ competitions - events that would likely move elsewhere if Ashburton becomes too challenging to operate at.
