Mayfield leads plant upgrades

New filtration and UV disinfection equipment came online at Mayfield's drinking water plant this week, in a seamless transition for the community.

Mayfield's water comes from a 119m bore and under new drinking water quality assurance rules it needed extra filtration, UV disinfection and chlorination.

Infrastructure and Open Spaces Group Manager Neil McCann said although the water from the deep bore had been safe to drink, Council was required to meet new national rules.

"Over the past few months our contractors have built a new building to house the new filtration and UV equipment and it will be fully operational as part of the treatment plant on Monday."

There was no disruption to Mayfield's water supply, which delivers drinking water to 68 households in the township.

Mr McCann said the project had been delivered on time and on budget by contractors ARC Projects.

"Our operations and maintenance contractor ACL will take over the running of the UV equipment after it has been commissioned. The instrumentation and control equipment at the plant talks remotely to Council and ACL, so it is monitored 24-7."

Mr McCann said Council was spending about \$10 million upgrading other water treatment plants around the district with UV and filtration equipment.

"At some plants we've had to construct new buildings to house the equipment and at others we'll be able to extend existing buildings to accommodate the UV and filtration. All the work is on target to be complete by the end of this year."

The Hinds water treatment plant needed a new building and that upgrade is nearly complete. Upgrade work at water plants at Argyle Park, Tinwald, Rakaia, Chertsey, Ashburton Domain and Bridge Street is under way.

Keep up the water services feedback, it's so important

Thank you to all those people who have given Council feedback on its plan to deliver water services in the future.

As at Wednesday morning, 90 submissions had been received and I hope more are coming, as this is one of the biggest decisions Council will make.

The future model for delivering drinking water, wastewater and stormwater services has been driven by Government's Local Water Done Well programme, and that is aimed at ensuring Council infrastructure up and down the country is fit for the job.

These are matters Ashburton council has done sensibly in the past and we think we've made good decisions, providing the pipes and plants our district needs.

One question that I have been asked during this consultation process is about the privatisation of water services

Government is committed to keeping

water services in public ownership, prohibiting councils and water organisations from privatising them (selling them off). We think the Stand-Alone Business Unit we chose as our preferred model is similar to the inhouse way we have run water services in the past.

Council would still own assets and manage water services and set water rates, and elected members would still oversee everything. The SABU model adds on the requirement to develop and implement a Water Services Strategy, comply with regulators and ringfence finances so that water revenue collected is only spent on water services.

If you have questions about this work, then I urge you to go to itsourplace. nz and look at the Frequently Asked Questions, as there's a lot of information there too.

Water of a different kind was on my mind this week too, when the national water-skiing champs got under way at a private lake. This event had been planned for Lake Hood but high cyanobacteria levels led to a health warning and the lake being closed. It was gutting for everyone.

Environment Canterbury continues to test water from the lake and we will advise the community of any change. One thing we know is that once cyanobacteria becomes established in a lake it is hard to get rid of, but it is a naturally occurring thing and something we will have to manage going forward.

It's been great to see lots of grandparents coming into Te Whare Whakatere this week, the first week of the school holidays. They're heading to the Ashburton Library for an Easter egg hunt or to play road trip bingo – there are also plenty of activities happening in other Council facilities, like the Ashburton Art Gallery and Museum and at EA Networks Centre.

SCHOOL SPEED ZONE

Council is extending the variable speed limit zone outside Tinwald School to include Graham Street, which means traffic must travel at 30km/h between 8.30am and 9.30am and between 2.30pm and 3.30pm on school days. The zone comes into force from 28 April.



MAKING A WREATH?

With Anzac Day approaching, Council is asking that groups and individuals making wreaths for the Cenotaph or other war memorials ensure they use colour-fast or nonleaching paint if making a wreath at home. Wreaths are traditionally left in place at the memorial for a week following Anzac Day so they must not leach colours into the stone.

The facility will be open on Anzac Day, 1-4pm and is inviting people to join them for a special Anzac Day talk with Sarah Johnston, at 2pm.

Sound historian Sarah is researching recordings made between 1940-1945 by New Zealand's mobile broadcasting units, which travelled overseas with our forces.

She will shed light on recordings the broadcasters made of New Zealand nurses. Courtesy of RNZ and Ngā Taonga Sound & Vision, she will play some of these 80-year-old recordings and talk about the men and women who we hear in them.

The inland high country zones of Mid-South Canterbury have moved to an open fire season status.

Ashburton Lakes, Rakaia Gorge and Rangitata Gorge had been in a restricted fire season status but that was revoked on Wednesday 16 April. That means the whole of the Mid-South Canterbury district is in an open fire season and fire permits are not required.

The Geraldine Forest Zone and all public conservation land remains in a permanent restricted fire status and permits are still required for open air fires in those areas.
