5. Covid-19 Economic Recovery Advisory Group

Minutes of the Covid-19 Economic Recovery Advisory Group meeting held on Wednesday 13 May 2020, commencing at 3.00pm, via Zoom.

The terms of reference, adopted by Council for the advisory group, were accepted.

5 Verbal updates from attendees

Bevan Rickerby:

Got essential services in Ashburton App at beginning of lockdown. Has been informing businesses of what is going on as much as possible. Directing businesses to the Chamber of Commerce website for advice. Developed a webinar series which is on the Council's website. Can use it for your own staff or for others within your sector. Webinar information will be shared after this meeting. There is the opportunity for some people within this group or other businesses to become mentors for others. Have been working with Ara to get some projects up and running to support reemployment opportunities. Run some courses to help support people seeking employment. MSD will be helping to fund this.

Mayor Neil Brown:

Council have reduced rates but did not cut any services. Important to keep projects going and keep spending to keep the economy going and create employment. Council are also ensuring they buy local where possible to do so.

Bob McDonald:

Retail sector pretty shaky at the moment. Talk of businesses reducing staff. Likely for a lot of people to be reducing hours of their staff.

Greg Donaldson:

All staff are back. Work to do but been having trouble getting permission to get on with Council work - possibly slower due to people working from home. Have laid out a staggered start approach for staff. Some people may have to work Saturday and Sunday. Advice from other contractors is that they are keen to spend locally and keep the local businesses running.

Greg was advised to get in touch with Neil McCann or Hamish Riach if he was experiencing roadblocks to get some work started again.

James Urquhart:

Rangitata Rafts have gone into hibernation for 12-18 months and some staff have been laid off. Owner/operators of accommodation businesses have been covering all tasks within their business to keep costs down. There are some hotel/motel businesses in Methven and Ashburton that will close if the budget does not offer any relief. Compliance costs (outside of Council) will be what puts the pressure on businesses.

Noted that Mt Hutt will be quickly going back to full speed when we get to Level 1. Will be looking to increase staff levels from 62 up to possibly 100.

Nicky Milmine:

Hospitality all currently open but quiet. A lot of restaurants are doing takeaway service. Staff hours have certainly been reduced.

Roger Sutton:

Selling less energy but still doing ok. Trying to give local contractors work to keep things going. Asked the question of how we get fundamental information out there for people in the community. Knowing what is happening around the place is important for people at a time like this. Advice is to do things in the economy that don't cost as much as bigger projects. Seeing that things are happening gives people hope. Let people in the community know that there is chance to revisit ideas/decisions.

Andrea Lee:

From building perspective – people are generally busy. Some builders have had jobs put off as customers are concerned about losing jobs. Some builders are not being compliant on site to date. Overall seems as though they haven't been hit too hard.

- Hamish Riach:

Snapshot from building and planning teams stats: have continued to do some consents work during the lockdown period and LIMs have started coming in again.

Simon Wareing:

Some parts of the business have carried on as normal and others have stopped completely. Farming has carried on relatively well during this period. Coming into winter now will be a slower time of the year. Not looking at any redundancies at this stage.

Aaron Chudleigh:

Have been busy throughout. Noted that the potato industry will be impacted globally. People are not eating at restaurants, etc. so this industry will be impacted by the reduction in demand. Biggest issue post lockdown is being short on staff. The business is heavily reliant on immigrant workers. A lot of people left New Zealand right before lockdown. Would love to be able to hire New Zealanders but not sure if there will even be enough people to fill the void of immigrant workers who have left. Question is how we get some of the unemployed people to this area to fill the jobs that are now vacant.

ANZCO and Talleys often take management teams out of town and out of the regions and provide rewards – happy to now support local and perhaps there will be some corporate deals that can be offered locally. If there were discount structures put in place for the big companies they could support this.

David Clark:

Trucking companies have been able to continue to service the farming industry which is a positive. Not confident the agricultural sector will be unaffected by the situation. Consumers will have less money to spend. Grain process holding up well. Beef prices have gone down. Regulation/compliance is having a huge impact on operating costs. A lot of dairy farmers rely on immigrant labour. Many are on visas and are here because of essentials skills. It would be easy for government to decide to try and get Kiwis to take up these jobs instead so there is a risk that some workers will not get their visas extended.

Contracting industry has been reliant on a lot of people travelling from overseas (e.g. the UK) and then going back home after 24 months. Where there were once low numbers of job applications from Kiwis, there has been an increase in applications. Need to give some thought to year round tourist activities. Projects and improvements on walking tracks for example should be put forward.

Karl Jackson:

Compared to rest of country, will possibly not come out of this too badly. Going to back to roots again and manufacturing and farming is what is going to prop this economy up. Need to focus on domestic tourism. Looking at this as an opportunity. Have projects ready to go and will be employing locals. Tourism for lwi has taken a hit. Will tentatively reopen some places in the spring and see what happens from there.

Michaela Blacklock:

Have been speaking the Labour Market Manager for Canterbury and is keen to be a conduit on behalf of this group at a regional level. The Regional Skills Leadership group is being set up at the minute and is also happy to act as a conduit for information in and out for this group. Canterbury Employers Chamber of Commerce has been contracted by NZTE (New Zealand Trade and Enterprise) and MBIE to run a helpline as a resource for everyone to use. If business owners need support, encourage people to call this number: 0800505096. This is a 12 month project.

The helpline is open to everyone, not just CECC members. CECC are updating their website daily and trying to keep information as accurate as possible for everyone to access. Business Mentors New Zealand is a government funded group and CECC work in conjunction with them. This group can be used for people who need this kind of support and mentoring. If people want to become a mentor within the community, Michaela is happy to act as the conduit for this but will also share the contact details.
