

# Council Minutes - 6 December 2023

Minutes of the Council meeting held on Wednesday 6 December 2023, commencing at 1pm in the Council Chamber, 137 Havelock Street, Ashburton.

#### **Public Forum**

Mark Somerville asked Council to consider making the accessible change rooms at EA Networks Centre solely for disabled people and their carers. He referred to the Rolleston pool complex disabled change facilities as a good example of what can be offered.

Concern in 2016 arose from reports of children 'playing' with the disabled change table. Council then agreed to provide some funding and move all the disabled equipment into two rooms, poolside. Mark explained that the intention of his submission at that time was that the two changing rooms should have signage to show that they are for disabled access only, but this didn't happen. The signs at EANC show that the change rooms are accessible, but don't preclude other people from using them. He said privacy is important and having to 'reserve' a change room can place additional stress on people who are unable to access mainstream facilities, including those whose disabilities are not necessarily 'visible'.

Mark commented that aerobic exercise in swimming pools is shown to help improve the quality of life for disabled people. He suggested that Council could possibly survey the community to see how many disabled people are using the EANC facilities, if those numbers are needed.

The Mayor thanked Mark for his explanation and bringing this to Council's attention. Officers will be asked to report through the February Activity Briefings and a report will be brought to Council, if required.

The presentation concluded at 1.16pm.

b. Section 2 - Rebalance the country's tax take between central and local government

c. Section 3 - Create stronger, more authentic relationships between local government and iwi, hapū and Māori

# Business transacted with the public excluded now in open meeting

- Stopping and sale of unformed legal road Valetta Westerfield Rd, Valetta
- **1. That** with respect to the unformed legal road shown as "Section 1" on Digital Title Plan SO 545925 (**Section 1**) adjoining Anama Westerfield Road, Council:
  - 1.1 seek approval from the Minister for Land Information (**Minister**) to close Section 1 pursuant to Section 116 of the Public Works Act 1981 (**PWA**);
  - 1.2 alternatively, if the Minister does not give approval under section 116 of the PWA, approves, in principle, the closure of Section 1 pursuant to section 342 and Schedule 10 of the Local Government Act 1974 (LGA);
  - 1.3 enter into an Agreement for Sale and Purchase for the sale of Section 1 to Willowbrook Farm Holdings Limited (**WFHL**) for the sum of \$49,710 plus GST (if any) on terms acceptable to Council officers and including the following conditions:
    - 1.3.1 that the road stopping process is completed in accordance with either section 116 of the PWA or section 342 and Schedule 10 of the LGA following public notification (if required) and subject to any objections being resolved in accordance with recommendation 3.2 below; and
    - 1.3.2 that Section 1 be amalgamated with WFHL's adjoining property contained in Record of Title 528158;
  - 1.4 pay WFHL the sum of \$875, being Council's contribution to the survey cost.
- **2. That** with respect to the unformed legal road shown as "Section 2" on Digital Title Plan SO 545925 (**Section 2**) adjoining Anama Westerfield Road, Council:
  - 2.1 seek approval from the Minister for Land Information (**Minister**) to close Section 2 pursuant to section 116 of the Public Works Act 1981(**PWA**);
  - 2.2 alternatively, if the Minister does not give approval under section 116 of the PWA, approves, in principle, the closure of Section 2 pursuant to section 342 and Schedule 10 of the Local Government Act 1974 (**LGA**);

- 2.3 enter into an Agreement for Sale and Purchase for the sale of Section 1 to Valetta Holdings Limited (VHL) for the sum of \$20,416 plus GST (if any) on terms acceptable to Council officers, and including the following conditions:
  - 2.3.1 that the road stopping process is completed in accordance with either section 116 of the PWA or section 342 and Schedule 10 of the LGA following public notification (if required) and subject to any objections being resolved in accordance with recommendation 3.2 below; and
  - 2.3.2 that Section 2 be amalgamated with WFHL's adjoining property contained in Record of Title CB40B/660;
- 2.4 pay VHL the sum of \$875, being Council's contribution to the survey cost.
- **3. That** if the LGA process is undertaken:
  - 3.1 Council shall issue public notice of its intention to close Section 1 and Section 2 in accordance with Clause 2, Schedule 10 of the LGA; and
  - 3.2 if any objections are received following the public notice, a subsequent report to Council shall be presented for Council to consider these objections, including whether to send
