The area of land involved in the application was mostly disused freezing works which could have easily been left as eye sore. With the existing land use classification being for meat processing and food processing, is very restrictive and it could remain in its present state for many years.

The specific provisions of the proposal that my submission relates to (please give details):

Although the Talley's group keep their properties tidy, it will still look disjointed from the adjacent Ashburton Business Estate. By approving the applicants' request for a plan change, this would bring the applicants' site to much the same conditions as the neighbouring business estate. This will allow the establishment of similar businesses and ultimately a more cohesive environment. The wider district will benefit from any increase in business brough about by this change.

The portion of **WORKS ROAD** on the applicants application is currently a private road and is partially closed. Will this become a public road? This section is very problematic. Recently a serious accident on the SH1 resulted in a traffic diversion, vehicles were turning into **WORKS ROAD** only to find it closed, which wasn't ideal for any motorists particularly heavy vehicles.

We believe the Council may need to look at the renaming of the roads. WORKS ROAD currently starts at the State Highway 1, then becomes JB Cullen Drive without any obvious change in the road as WORKS ROAD veers off to the left by what is seen as an intersection controlled with a Give Way sign. We propose that JB Cullen drive extends to SH1, whilst WORKS ROAD begins at the existing intersection of JB Cullen Drive and WORKS ROAD, continuing through to Fairfield Road West. Whilst it is not of concern to us, Office Road and Company Road, also have sections that are private, perhaps this also needs reviewing.

A change to Works Road could be achieved with ease at this time due to only one farm cottage being affected. If changes were to be delayed, future developments on both the applicant's site and the wider Ashburton Business Estate would create unnecessary disruption and more confusion.

**Current layout** - Works Road (continuous yellow line) starting from SH1 and turning into a private road (Yellow dotted line). JB Cullen Drive (blue continuous line).



**Proposed Changes** – JB Cullen Drive (blue continuous line), starts at State Highway One. Works Road (yellow continuous line), starts at the intersection of JB Cullen Drive and continues through to Fairfield Road West. The other roads mentioned above which need reviewing are Office Road (Green line) and Company Road (Red Line).
