# Glow visitors tick over 59,000

Glow in the Park organisers are looking at visitor data collected during the King's Birthday weekend event, but they are already counting it a big success.

About 59,000 people came to the Ashburton Domain over three nights and were dazzled by the free, community light

Mr Hyde said the Eiffel Tower proved to be a popular photo spot on the light trail, followed by the inflatable jungle animals.

"And there were also lots of people stepping off the trail to see the illuminated spheres floating on the domain pond. We had more food trucks on site at this year's event and they appeared to be doing steady business."

Mr Hyde said Council was grateful to the local businesses who sponsored the event, including EA Networks as the naming sponsor.

# Methven's plan for progress

The Methven Community Board is wasting no time setting about implementing its newlyadopted strategic plan.

Chair Kelvin Holmes said one of the issues that had surfaced during consultation on the strategic plan was about the need to improve pedestrian safety.

"We had some great conversations with our community as part of the work to update our strategic vision for Methven and one theme that emerged was that the town needed some more pedestrian crossings so people young and old could move about

"We've begun talking with the district council and NZTA about pedestrian crossings and we'll report back to the community soon on progress.'

The community strategic plan was adopted at the community board's meeting last week and Mr Holmes said he was proud of its vision.

# Info session for candidates

Council is hosting a candidate information session on Wednesday 18 June and anyone thinking about standing for Council or the **Methven Community Board in the Local** Elections later this year can come along.

The session will be at Te Whare Whakatere, Council's offices, at Baring Square East, at 5.30pm, and potential candidates can learn all about the election process and ask questions.

Chief Executive Hamish Riach said the information session would give potential candidates a good idea of how the election process worked and what was required to be a candidate.

"We'll also have our Electoral Officer there to talk about how the election will be run."

There are about 28,400 eligible voters in the Ashburton District and later this year they will be asked to elect a Mayor and nine councillors, as well as a Methven Community Board and other community representatives.

Mr Riach said key documents would also be available at the information session, including a pre-election report, nomination forms and candidate handbooks.

"The pre-election report is generated ahead of every local election and is designed to give potential candidates an overview of the district and the challenges ahead.

"Councils are responsible for a broad range of services, from making sure water flows from the taps, to managing building consents and providing libraries and parks. Councillors are elected to have a governance role in these important community services, as well as planning for the future.

"Anyone is welcome at the information evening, and even if you're not sure about standing quite yet we'd encourage you to come along and find out a bit more about the process."

Nominations open on 4 July. Voting documents will be delivered in September, with voting closing at midday on 11 October.
