**Re: Ashburton District Council Annual Report**

I write in reply to your letter of 17 April 2014 concerning our annual report on the proceedings and operations of our District Licensing Committee (DLC).

The following information is submitted as per the report template referred to in your letter:

**1. Overview of DLC Workload**

DLC Structure and personnel: We have a combined DLC with Selwyn plus 2 secretaries and a part time inspector (25 hours per week). See attached details.

Staff Training: DLC members and relevant staff attended LGNZ KnowHow Workshop - DLC Training on 24 October 2013 plus subsequent training for DLC members from former Judge Hole and a workshop with Judge Unwin on 13 Mar 14 plus various in-house training at Selwyn.

Business changes: There has been a notable increase in administration and paperwork with much more time spent on this compared to that with the previous DLA. This has also increased overall costs.

DLC Meetings: No Hearings held during reporting period. See attached Annual Report for breakdown of applications considered at DLC Meetings held.

No noticeable trends faced by the DLC

**2. DLC initiatives**

No new initiatives have been trialled outside of the procedures and practice notes available.

**3. Local Alcohol Policy**

Our draft LAP was adopted for consultation on 3 October 2013 and preliminary decisions have been made. Final decisions and notifications are on hold pending the outcome of appeals lodged against the Tasman and Waimakariri District Council policies.

**4. Comments on current Legislation**

Legally accepted guidance notes on the application of the Act would be welcomed to overcome the many personal interpretations and opinions on best practice provided via ListServe.

We would also recommend that the criteria for Special Licences be amended to reflect more of a risk based approach rather than the number of people attending the event.

**5. Any other matters**

There is insufficient training available on the new Act for licensing inspectors and recommend MoJ provide training courses.

We also recommend that MoJ produce templates for applications and licences. This was done in the past but has been discontinued.

We are continually bemused at the requirement to courier paperwork to ARLA which could be sent electronically instead.

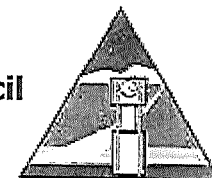

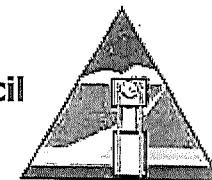

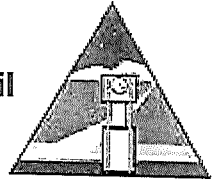
