Having worn many hats / and had many titles during my thirty six years residency in Ashburton District. I have been in a fortunate position to work alongside and witness many talented people, businesses and yet still see opportunities for more. Some such examples, may include, but are not limited to:-

Additional Secondary School options

While it has offered an alternative, that the Ashburton Christian School has extended classes to include secondary school years. I have no data on how many Ashburton School students, complete primary / intermediate education then leave the district to attend Boarding Schools, my personal observations are quite a lot take that route. I suspect this has a detrimental impact on the local economy, as those students, their families and supporters then are away from the Ashburton District more frequently. Conversely to that, if there were additional education offerings in the Ashburton District, we may well see, more discretionary spending from students and their families within the Ashburton District.

Christchurch – As of 2023, the estimated population of Christchurch is 443,774.

-> has *eight boarding schools* (*Christchurch Boys' High School * Christchurch Girls' High School * Christ's College * Rangi Ruru Girls' School * Selwyn House School * St Andrew's College * St Bede's College * St Margaret's College)

Oamaru – as at June 2022 has an estimated population of 13,900

- -> has *three boarding schools* (*St Kevin's *Waitaki Boys School *Waitaki Girls School) **Timaru** – as at June 2022 has an estimated population of 48,500
- -> has **three boarding schools** (*Craighead * Timaru Boy's High School * Timaru Girls' High School)

Conservatively estimating that just 20 pupils attend each of the fourteen schools (and that is just 4 people each year, each school), with an average of \$25,000 per year.

 $20 \times 14 = 280 \times $25,000 = $7,000,000$ per annum in boarding school fees alone Discretionary expenditure for 280 people – may be \$100 per week = \$28,000 per week = \$1,456,000 per annum

Discretionary expenditure for families visiting out of town pupils = 560 people \$ 100 per week = \$2,912,000 per annum

I suggest that if an additional Secondary School / Boarding School were to establish in the Ashburton District, this may address some of the concerns raised by submitter Stacey Smith.

Tertiary Education

It was 2001, that Southern Institute of Technology in Invercargill, introduced the SIT's Zero Fees scheme. It is estimated that SIT's Zero Fees scheme contributes about \$157.1 million to the region's economy annually, while 40% of graduates end up working in Southland, the independently produced economic impact assessment says.

While Ashburton currently does not physically have Tertiary Education facilities in the district – population growth and forecasts would indicate that there will in the future be a time that it should.

As explained in the SIT article, the wider economic benefits and pipeline for employees are an additional bonus.

While Ashburton Hospital works closely with University of Otago, there may be other tertiary institutions wanting to connect to Ashburton district.

With Rolleston Film studios less than an hour away, and having personally hosted studio personnel, to the Ashburton District to view accommodation options - such as Montrose Estate and Brinkley Resorts Have witnessed an increasing number of productions visiting the district. However, if we reflect on the Lord of the Rings Trilogy – there was a missed opportunity. Alpine Safaris host Lord of the Ring tours to the Edoras site. The film set was dismantled form this location post production – when you compare a single tour operator, driving to a location, which essentially is about showcasing the set vista, to the Hobbiton Movie Set, Hinuera, Waikato – conservatively estimate 650,000 per year @ \$ 70 per ticket = \$ 45,500,000 – prior to COVID 19 employed 280 staff

Dark Sky Tourism

I recall that CEO Hamish Riach and I attended a presentation on Dark Sky Tourism - and have watched with interest as foothill communities are publicly seeking support for Dark Sky Tourism in the Ashburton District. Alternatively, this may well be a good fit for Mt Hutt or Methven – ADC may be party to navigating potential parties and

This year, Tekapo opened its new Dark Sky Project, a venture half-owned by Ngāi Tahu, which connects Māori astronomical storytelling with standard astrotourism. Forty thousand visitors a year visit the attraction, and for the year to May 2019, tourism contributed \$298 million to the Mackenzie District economy.

While there are not currently retailers, hotels, motels up at the Ashburton Lakes and Tourism may not see a direct benefit from day (night trippers) that may attend – there would be an indirect benefit to hospitality, service stations and more. Regent Cinema have experienced a similar impact from the arrival of K-Mart. We've spoken with day trippers from Timaru, Fairlie, Dunsandel, Darfield – who've chosen to visit Ashburton K-Mart, then look to have lunch, dinner or attend a movie around their visit.
