8 Hekeoa Hinds Water Enhancement Trust update

There are plans to expand the scheme to conclusively prove that in parts of catchment, making positive difference and in some cases a significant improvement, in conjunction with on farm nutrient leaching reductions and MAR.

Brett is to put together a report outlining barriers that HHWET are facing and what will inhibit this project from continuing.

9 Carters Creek Catchment Group Update

Willy Leferink, Janine Holland and Keith Gundry (2.26pm to 3.01pm)

Following the significant rainfall in July, Tinwald residents adjoining Carters Creek were inundated with water from excessive storm water flows from Carters Creek. The creek does not have capacity to handle the water flow

Catchment groups members want to understand who can help them stop their homes and buildings from flooding as they clean up rubbish and debris, attempt to repair eroded creek banks, assess damage to gardens/infrastructure and prepare for next storm event. Would like to establish a way that Ecan, ADC and the residents can work collaboratively to fix these issues.

It was noted that Carters Creek upkeep is included in the Zone Committee Action plan 2021/24. Environment Chair Peter Scott has asked Cr Mackenzie to look into possible solutions.

I am writing to express the committee's support for the ongoing work of the Hekeao Hinds Water Enhancement Trust.

At the 29 August Meeting of the Ashburton Water Zone Committee Dr Brett Painter updated the Committee on the Hekeao Hinds Water Enhancement Trust's (HHWET) analysis of monitoring data for 2022-23.

This analysis shows ecosystem health improvements in receiving groundwater and Hekeao Hinds waterways resulting from the current Integrated Catchment Management (ICM) scheme – comprising environmental infrastructure components in combination with on-going improvements on-farm. They anticipate the ICM scheme will result in an improved environmental footprint and reduced long-term operational costs compared with the original PC2 concept.

Our Mid Canterbury Vision

Mid Canterbury's intergenerational vision is for a thriving and resilient community who are environmentally responsible, culturally respectful, economically viable and socially cohesive, recognising these aspirations are interdependent on one another and underpinned by water.

Our Foundations: Environmental, Cultural, Social and Economic

Environmental

Through responsible stewardship and sustainable practices, we will preserve and enhance the health of our water, land, biodiversity and ecosystems to ensure they remain a source of life, prosperity and wellbeing for generations to come.

1. **Healthy State of the Environment:** Rivers are healthy, swimmable, and abundant with life. Aquatic ecosystems flourish, people can enjoy the amenity and recreational value of the environment and mahinga kai opportunities.
2. **Management of Natural Resources:** Ensuring that natural resources are managed in a way that preserves the health and integrity of existing ecosystems, protecting flora and fauna and maintaining the ecological balance, while still providing for the viability of the community. The community's management and use of natural resources needs to reflect the need for flexibility over time and the interconnected nature of the resources.
3. **Sustainability:** The sustainability principle aims to ensure that human activities are conducted in a manner that meets the needs of the present without compromising the ability of future generations to meet their own needs. Humans have an interdependent relationship with natural resources, we depend on them to thrive, they depend on us to thrive. 5. **Ambitious and achievable targets:** These foundations highlight the importance of long-term knowledge to guide practical management, community involvement, and decision-making. Our community is conscious of all costs and trade-offs, and clear regulations in achieving sustainable water and soil management and environmental conservation, recognising human habitation and the delays between catchment action and evidence of this in the environment.

Cultural

These key foundations reflect a desire for an inclusive, respectful and diverse community for all cultures, respecting the bi-cultural relationship with mana whenua, and the role of Te tiriti in promoting unity for common and shared outcomes now and for generations to come.

1. **Striving for an inclusive Community:** Our vision is to foster a united and inclusive community.
2. **Growing Understanding and Respect:** We envision a future where there is an opportunity for all cultures to develop a deeper understanding of each other's values and aspirations. By encouraging transparent and respectful relationships, we aim to navigate differences and collaborate toward shared goals for a sustainable and prosperous community.

Social

This foundation includes a diverse and thriving community that is socially cohesive. We prioritise health and education, safe environments, and strong infrastructure to create opportunities, stability and support our families and businesses.

1. **Health and Well-being:** Healthy communities are underpinned by a healthy environment. They enable the physical and mental health of all community members to be met.
2. **Strong, Safe Community:** Close-knit, engaged, inter-generational, collaborative communities, with strong identities where safety and security is paramount. Supporting local families, schools and community amenities underpins our social fabric.

- Limestone and fossils right by the gate when we walk in
- Different plant species and talked about their role in a wetland
- Wetland birds and the species Russell has including his newly established raupo wetland, hoping to attract bittern
- What's in the water? Eel, mudfish, native fish, freshwater mussels and crays and macroinvertebrates
- What's relying on the wetland? birds, bees, butterflies, dragon flies, crickets etc

Sophie Blair, the facilitator of the Lagmhor Westerfield Catchment Group, will give an overview of Riverbridge Conservation Park and the Riverbridge Native Species Trust, Russell Langdon's grandson Ben talk about their plans for the future, and Hampstead School student Jakob Blampied will talk about their visit to the wetland.

Report

1. Election of Officers

Each year, the Committee will appoint a Chair and Deputy Chair from its members. There is no limit on how long a person can be in this position. The Committee's last elections were held on 23 August 2023.

As a Committee member the Chair shares the same responsibility as other Committee members.

In addition to this the Chair has the following roles:

- Chair Zone Committee meetings with all the commonly recognised authority of that position. The Chair may have the Zone Facilitator facilitate meetings and workshops of the Committee.
- Speak on behalf of the Committee and act as an advocate for it, including taking primary responsibility for interaction with the media and representing the Committee at meetings with external parties.

The Deputy Chair exercises the same roles as other members, and if the Chair is absent or incapacitated, the Deputy Chair must perform all the responsibilities and duties of the Chair (as above).

2. Chair

After many years of service in the position of Chair Bill Thomas has decided not to stand for the role this year.

To date, no other members have nominated themselves, or been nominated, for the role of Chair. If there are no nominations at the 26 September 2023 meeting, Bill Thomas has expressed willingness to continue in the role until the refresh process next year. The refresh process will be completed by June/July with new members likely to be onboard by August 2024 at which point a new election for Chair and Deputy will be held.

3. Deputy Chair

Currently Chris Allen holds the position of Deputy Chair. If no other nominations are received Chris is also willing to stay on in the role until the refresh process is complete.

Recommendation

That:

1. If any nomination for Chair is received, the Committee hold an election for the role.
2. If no nomination for Chair is received, the Committee resolve to extend Bill Thomas's term in the role of Chair until August 2024
3. If any nomination for Deputy Chair is received, the Committee hold an election for the role.
4. If no nomination for Chair is received, the Committee resolve to extend Chris Allen's term in the role of Deputy Chair until August 2024.

Process to Elect of Chair and Deputy Chair

(ref. Schedule 7 clause 25, Local Government Act 2002)

For the election or appointment of the chairperson and deputy chairperson, a local authority or a committee (if the local authority has so directed) must **determine by resolution that a person be elected or appointed by using one of the following systems of voting:**

System A:

- (a) *requires that a person is elected or appointed if he or she receives the votes of a majority of the members of the local authority or committee present and voting; and*
- (b) *has the following characteristics:*
 - (i) *there is a first round of voting for all candidates; and*
 - (ii) *if no candidate is successful in that round there is a second round of voting from which the candidate with the fewest votes in the first round is excluded; and*
 - (iii) *if no candidate is successful in the second round there is a third, and if necessary subsequent, round of voting from which, each time, the candidate with the fewest votes in the previous round is excluded; and*
 - (iv) *in any round of voting, if 2 or more candidates tie for the lowest number of votes, the person excluded from the next round is resolved by lot.*

System B:

- (a) *requires that a person is elected or appointed if he or she receives more votes than any other candidate; and*
- (b) *has the following characteristics:*
 - (i) *there is only 1 round of voting; and*
 - (ii) *if 2 or more candidates tie for the most votes, the tie is resolved by lot.*


