## All welcome at awards launch

Local businesses, big and small, are being invited to a launch party for the Ashburton District's Business of the Year Awards.

The free event will be at Smoke, on Tuesday 5 August from 6pm, and there'll be plenty to encourage potential entrants, including some words of inspiration from 2024 supreme winner Opuke Thermal Pools & Spa.

The 2026 awards have 14 categories and entries will open on the night of the launch party. Businesses will have until 31 October to get their entry forms in, with winners announced at a gala dinner on 20 February.

Mayor Neil Brown said the categories ranged from primary industries and environmental sustainability to retail, tourism and customer experience.

"There'll also be awards for business leaders and emerging businesses. We know businesses of all kinds make this district tick so I encourage them all to come along to the launch and find out more about the awards.

"We can get so busy working in our businesses that we forget to recognise our achievements along the way."

Council is partnering with event organiser Ri Ra once again to run the awards, and ANZ is back as the event naming partner.

The business awards are held every two years and a gala dinner to announce category winners and a supreme winner will hosted be at the Ashburton Aviation Museum on 20 February, 2026.

The aviation museum was a winner in the 2022 awards, taking top spot in the tourism category, and the gala dinner will be held in their super hangar. The supreme winner that year was NZ Sock Co, which has turned sock-making into a science

Mayor Brown said the awards were a great opportunity for Council to recognise and offer encouragement to the district's businesses. "We have some super operators and it's great to celebrate their success"

## Last week to avoid doggy late fees

With just a week to go, around half of the district's 7000 dogs have been registered and the Council is giving the rest a friendly bark - fetch your form and get cracking!

Compliance and Development Group Manager Ian Hyde said it wasn't unusual to see a scramble in the final week but cautioned dog owners against leaving it too late. "We want people to avoid any late penalties, so if your registration form has been sitting on the kitchen bench or stuck to the fridge, now is the time to jump online and get it sorted."

Mr Hyde said dog owners were increasingly enjoying the convenience of online registration, with around 56 per cent of registrations processed through the Council's website so far.

"Of course, our customer service team is ready to help anyone who doesn't have internet access or prefers to complete their registration in-person. They can also help if your dog needs a replacement metal tag."

Legally, all dogs over the age of three months need to be registered by 31 July. Registrations can be completed online at ashburtondc.govt.nz/dogs

# MAYOR Neil Brown **Essential business, as usual**

The Local Government conference in Christchurch last week provided a chance for Government to repeat its message to Councils to get back to basics ... and that is largely business as usual for us here in Ashburton.

We've been told to prioritise essential services, spend wisely, invest in core infrastructure and deliver value for money

I think these are things we have been doing in the Ashburton District, and the numbers in our Annual Plan – a public document on our website – support that If you look at our budget by activity, 80 per cent of it is spent on roads, three waters, rubbish, regulatory services and recreation facilities. Doing that 80 per cent will help us support another Government directive, which is to support local economic growth and development by doing the basics right!

You may also have heard the media and Government talk about capping rates and yes, rates rises do need to be managed, but not at the cost of passing a problem on to future generations. If councils gather less rates than they need to provide essential services, then levels of service inevitably reduce.

One thing clear at the conference was that Councils are in challenging

times and they sometimes have to make tough calls. Equally clear was that we are up for it, and doing our best.

From big infrastructure to consistently doing all the little things right, we need to have a solid platform for communities to live, work and play.

Another essential responsibility for Councils is civil defence, and we only have to cast our minds back to 2021 and 2022 to know the damage that floods can cause.

Being prepared is key so that we can reduce risk, be ready, respond, and

## **Grants open for creative projects**

Whether you're producing a play or hosting an exhibition, groups or individuals with a local arts project can apply for financial help through the Creative Communities Scheme from 1 August.

Council administers the scheme on behalf of Creative Communities New Zealand, and this round there is a pool of about \$18,000 to distribute.

Democracy and Engagement Group Manager Toni Durham said the range of arts projects supported by Creative Communities was broad.

"In the last funding round, Mt Hutt College was granted \$733 to help put on Murder She Floats, which is their school production. The show is on for three nights at the end of this month, and one night is already a sellout.

"A school production is a big event and it involves lots of voluntary hours, as well as cost. Being able to tap into the Creative Communities scheme is a boost for all those involved."

Other previous recipients include the Ashburton Festival of Pipe Band Music, the Hakatere Ceramics and Pottery group, the fairy walk at the Methven and Foothills

Walking Festival and the Mid Canterbury Children's Trust.

Funds granted for arts projects must be used on things like production costs, materials, venue or equipment hire and promotion. There's no limit to how much you can apply for, but most CCS grants are under \$2000.

Mrs Durham said applications open on 1 August so those with an arts project should start looking to see if they might qualify for a grant.

"The grants are administered by Council and the assessment committee includes councillors and community members. Committee members are all invested in the arts in our community and look forward to seeing your applications."


#### King and Alexander Streets, Chertsey

- Closed until 13 September while a new water treatment plant is built. The road closure does not impact school access.

**Philip Street** - Closed between Oak Grove and Grigg Street until Friday 25 July while new water pipes are installed by Rooney Earthmoving. Resident access remains.

Tancred Street - Closed between William Street and Chalmers Avenue from 14 July to 29 August while new water pipes are installed by Rooney Earthmoving. Resident access remains.

### Water pipes connected at Argyle Park plant



Parts of Allenton may experience low water pressure over the next three weeks as part of work to upgrade the Argyle Park water treatment plant.

The plant is currently shut down while contractors are connecting the existing bores with pipework and UV equipment that is being installed in a new building next to the existing facility on Middle Road.

The work has the potential to create low water pressure because Allenton will be serviced by other treatment plants on the Ashburton network while the Argyle Park plant is offline. Water from the tap remains safe to drink.

Low pressure might be more noticeable in the morning, when many households are using water at the same time as people prepare for work or school; pressure may also be lower in the early evening because of high demand.

The upgrade project is an important milestone in a year-long programme to add UV disinfection at all Council drinking water supplies around the district.

The new UV equipment is on track to be fully operational by the end of August.
