## 8 Hekeao Hinds Water Enhancement Trust – Brett Painter/Peter Lowe/Rab McDowell

- Hekeao Hinds Water Enhancement Trust (HHWET) are currently running workstreams to trial Managed Aquifer Recharge (MAR), Near River Recharge (NRR), and Nutrient Recycling through ground water irrigation.
- The original MAR sites are well into their sixth year of operation.
- Results to date are available through the HekeaoHindsWET Facebook page or [www.hhwet.org.nz](http://www.hhwet.org.nz)
- Positive progress is continuing regarding improved water quality and management of groundwater levels.
- The river reach below the south Hinds/Hekeao NRR1 site has also shown increased fish populations.
- HHWET are supporting workstreams led by other organisations to trial Constructed Wetlands and solar powered Targeted Stream Augmentation (TSA).
- HHWET are currently preparing consenting documentation to support applications to increase MAR and NRR trials up to catchment scale, as per the Ashburton Zone Committee's Zone Implementation Plan and Addendum.
