## 1.1 Summary of feedback received

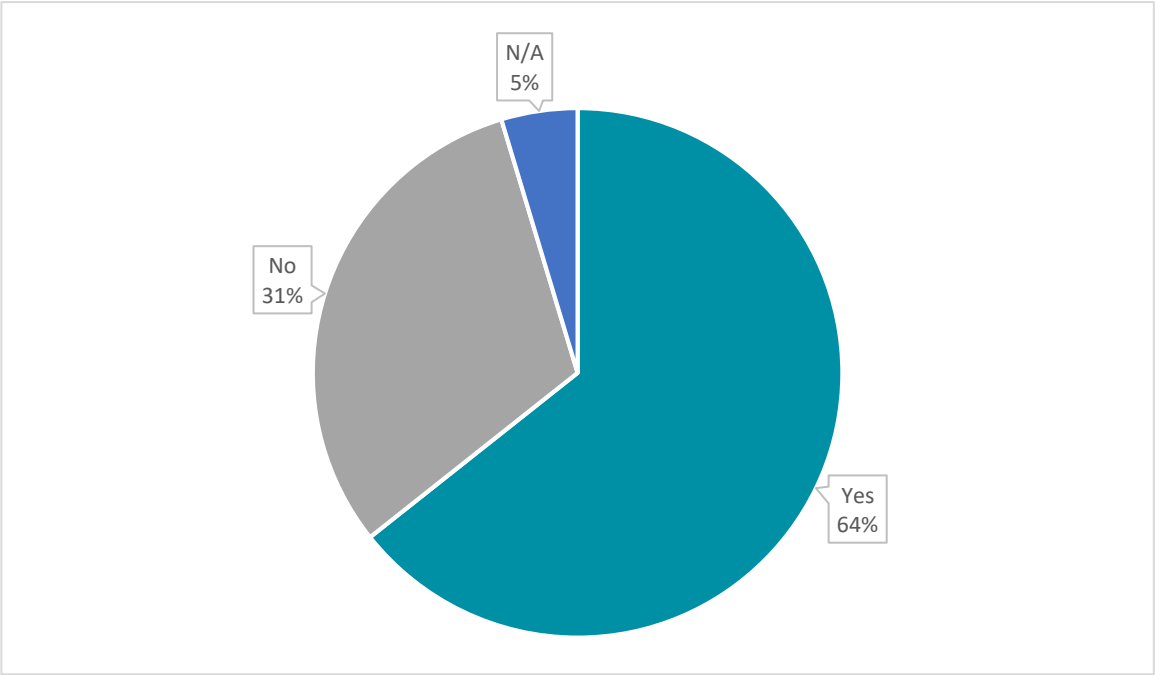
Public consultation on the Draft Waste Minimisation and Management Plan was undertaken from Monday 23 May to Thursday 23 June 2022.

- A total of **130** submissions were received.
- **127** submissions received on time.
- There was **3** late submissions received as at Tuesday 28 June 2022.
- **9** submitters indicated on their submission form that they wanted to be heard (**5** are confirmed as attending as at 30 June 2022).

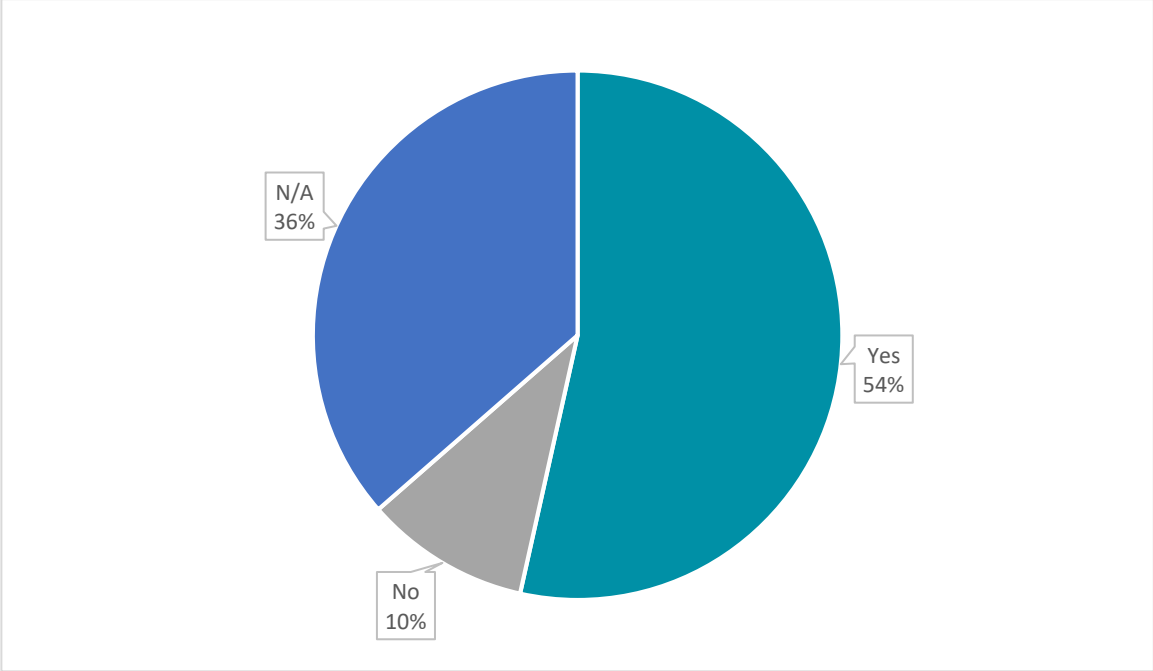

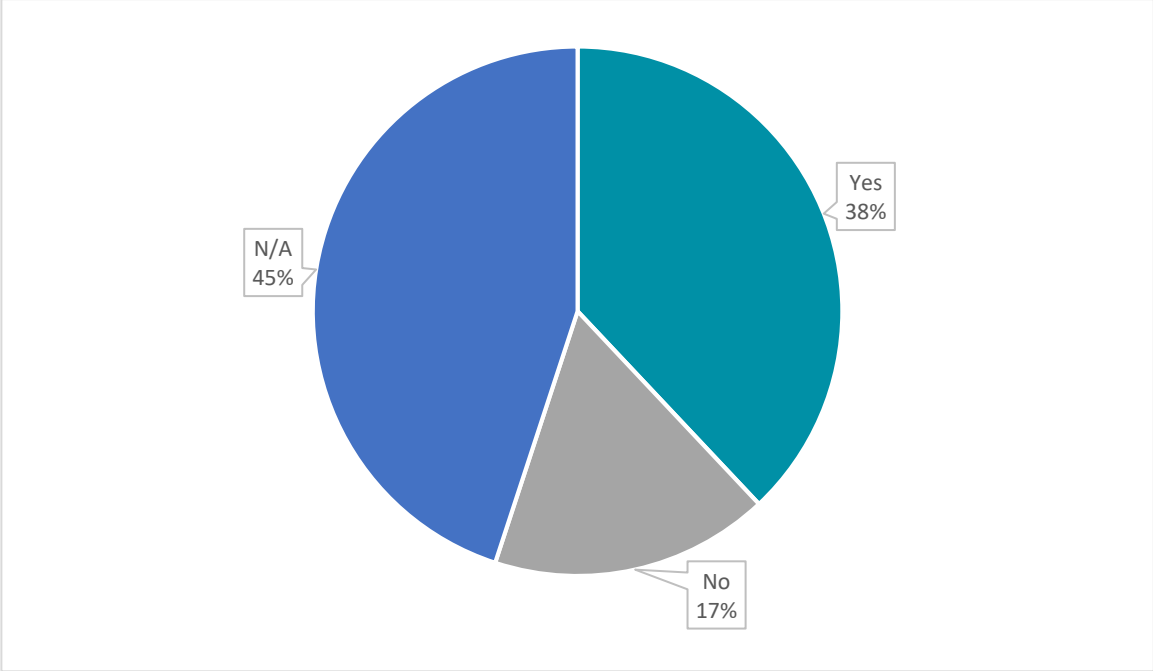
